John Maietta will be our speaker for the October luncheon. The title of his presentation is as follows:

From Aspirin to the Zipper: The Amazing History of Ordinary Things

We're surrounded by mundane objects the we use every day, but most of us don't have the faintest idea where they came from. 

Directions to Luncheon:



Legislative Report:

Mark McKillop died on Mon. July 18, 2022

The following are highlights from the LPEC State Committee Meeting held on May 11th:

It was announced that a meeting between Senate Appropriations Committee Chairman Senator Pat Browne and Mark McKillop was being planned regarding support for a COLA.

A PSERS update was discussed.

A motion was passed for a "Guest Editorial." to be written by PASR's Executive Director concerning a COLA. (Such a letter appeared in the Patriot News on June 21, 2022).

It was announced that Channel 21 (CBS affiliate in Harrisburg) planned to interview Mark McKillop and one other person who is a leader in PASR about our need for a COLA. (The interview actually took place May 16th).

IN OTHER NEWS:

According to Round-up - Governor Tom Wolf - PA.GOV, an official website of the Commonwealth of PA, the 2022-23 PA budget (passed on July 8th) projects having a \$3.6 billion surplus at the end of the fiscal year 2022-23 and deposits \$2.1 billion of that surplus in the state's Rainy Day Fund. The \$2.1 billion deposit will raise the balance in the state's Rainy Day Fund to \$5 billion but will still leave the state with a surplus of 1.5 billion.

COMMENTARY ON THE ROUND-UP MENTIONED ABOVE:

The annual amortized cost of PASR's 2018 proposed COLA was \$90.2 million. The total amortized cost of PASR's 2018 proposed COLA was \$900 million. That \$900 million represents 4.28% of the \$2.1 billion placed in the Rainy Day Fund. Reserving \$900 million of that \$2.1 billion for a COLA would still have left \$2.0001 billion (95.72% of the \$2.1 billion) to be placed in the Rainy Day Fund.

The General Assembly could have used just 4.28% of that \$2.1 billion budget surplus to fund a desperately needed COLA for retired public school employees. Incidentally, not one penny of the state's end-of-year surplus was used to reduce the unfunded liability of PSERS' retirement account, a liability caused in large part by the General Assembly itself.

PASR members might wonder what one can do to change things. For the past 20 years, the same political party has held control of the PA General Assembly. Over that period of time, **NO COLA LEGISLATION** has been introduced, much less passed even in 2022 when for the first time in those 20 years the state **HAS THE MONEY** to do so.


