
#### Social Service/Memorial Honor Fund

## Legislative Report:

PSERS – In the News

PASR Statement on PSERS

For the year 2022, meetings of the State Legislative/Political Education Committee (L/PEC) are being scheduled five times throughout the year rather than monthly. Highlights of its 1st meeting, held on Jan. 13, are as follows:

Reports from PASR's lobbyist, Triad Strategies, indicated that:

- I. Representative Frank Ryan, Vice Chairman of the PSERS Board of Directors, is advocating for changes in investment strategies of PSERS, changes in the composition of the PSERS Board of Directors, and increased financial literacy training for PSERS Board members.
- 2. Triad Strategies PASR will help guide PASR's testimony regarding the need for a COLA to the appropriate political entity. Such testimony would be timed to take advantage of foreseen and/or unforeseen political events so that maximum impact and acceptance would be achieved.
- 3. Triad spoke with the Governor's team and the Governor's Office is open to a consideration of a CQLA.

#### **LEGISLATIVE** Continued from Page 5

#### PASR's Executive Director, Mark McKillop reported that:

- I. Regarding PSERS, he will be submitting questions posed by L/PEC State Committee members to a particular PSERS Board member and he will ask for a written response.
- 2. Regarding PA Congressional Redistricting, he felt that such a plan would likely be decided by a state court and he took the L/PEC Committee through the various state courts that would be involved if appeals were filed against lower court decisions. The US Supreme Court could even be involved if it agreed to hear such an appeal. Just as a reminder, PASR's two main priorities for 2022 is a COLA for all retired PA public school employees and monitoring the activities of PSERS. Also, please understand that the timeliness of these written reports are affected by the meeting dates of the State L/PEC Committee and the mailing dates of the chapter newsletter. The feeling is that this particular difficulty should not preclude reports about State L/PEC Committee meetings.
