
#### Death Becomes Her on Broadway

## LEGISLATIVE REPORT

### November 2025 LEGISLATIVE REPORT

The General Assembly has finally passed the 2025–2026 state budget—135 days late, well beyond the June 30 deadline. During this prolonged impasse, PASR's State Legislative Committee suspended meetings and lobbying efforts, as the status of a COLA remained uncertain. That decision point should soon be clarified.

#### PASR's Position on COLA

PASR's stance remains unchanged: **Any COLA must apply to all Pre- and Post-Act 9 annuitants.**

- As of September 30, 2025, Pre-Act 9 annuitants require \$180.54 to purchase what cost \$100 on July 1, 2002—the effective date of the last COLA.
- Post-Act 9 annuitants who retired between July 1, 2002, and June 2007 now need \$155.89–\$180.54 to purchase what cost \$100 at retirement.

If no COLA is included in the current budget, future proposals must account for the **10%+ loss of purchasing power since June 2023**. Otherwise, new versions would provide less relief than earlier versions.

#### Education Subsidy and Budget Delays

According to PSEA, the **2024–2025 basic education subsidy** totaled **\$8.16 billion**, or roughly **\$680 million per month** across Pennsylvania's 500 school districts. With the state five months behind on payments:

- If installments had been invested at 3% annually (0.25% monthly), they would have generated \$25.5 million in interest over five months.
- Key questions remain:
  - o Will this interest be returned to school districts that borrowed to cover expenses?
  - o Will it be used to balance the budget, bolster the Rainy Day Fund, or fund a COLA?

#### Implications for School Districts

This situation underscores why districts must maintain substantial reserve funds to withstand late budgets. Inevitably, those reserves come from local property taxes—a direct burden on taxpayers. Voters should remember these consequences when evaluating legislative performance.

## Scholarship Committee Report

Remember when college tuition for one year was \$500, \$1,000 or \$2,000? Those days are long gone, and future college students face long-term student debt when earning a college degree. Economists and talking heads are publicly and loudly questioning whether a college degree is worth such financial obligation. As we all are aware, this uncertainty, as well as salary; working conditions; parental pressures; and pension planning, have negatively impacted the number of qualified individuals deciding to make Education a career choice. Our members who worked with students in various capacities have experienced how critical good educators are, and CCCPASR long ago established a goal of assisting future educators by awarding scholarships throughout the years.

Because of the generosity of our members—through donations and participation in raffles at our luncheons—the Executive Board approved increasing the number of scholarships awarded in 2026 from two to three, each valued at \$1,500. Everyone who has contributed to the Scholarship Fund should take pride in knowing that you are helping aspiring young students who will go on to educate future generations, including your family, friends, and community members.

The Scholarship Committee is asking for your help in spreading the word about this opportunity. A copy of the CCCPASR Scholarship Application is included in this newsletter. Please share it with any qualifying student you know. Students should also be informed that guidance counselors in all ten schools where our members have worked will have applications available. This is a wonderful chance for each of us to give back and ease some of the financial burden for these students—while doing it with a smile on our faces!


